Appointment of trustees: As of 14 May 2008, VSSN members elect up to nine trustees to

serve a three-year term of office on a rolling basis, with three elected at each Annual General Meeting. The editor of *Voluntary Sector Review* serves as an ex-officio member. An additional two trustees may be co-opted. This is the second year since the introduction of the new voting rules: the initial terms of office are set according to the results of the Single Transferable Vote on the annual cycle of three members to be elected each year. Trustees

may serve for a maximum of six consecutive years.

As of 2 December 2009 a sub-committee was elected to act as the Editorial Management Board (EMB) for the journal *Voluntary Sector Review*. publisher, The Policy Press.

## Steering Group Report: VSSN activities undertaken for public benefit during the year ending 31 July 2010

This has been a year of significant progress within VSSN. Combined with the Steering Group's continued commitment to work with members and other partners to develop the Network, VSSN has seen the successful launch of the new journal *Voluntary Sector Review*, published by The Policy Press. This and other work consolidates VSSN's position as the key organisation serving the UK voluntary sector research community. Key highlights are summarised below.

#### New Journal: Voluntary Sector Review

With The Policy Press, the VSSN launched the new journal *Voluntary Sector Review* in Spring 2010. Focusing on the third sector, this is a major development for the Network and for the voluntary sector research community as a whole. There are three issues published per volume each year. Members will have received the first three issues forming volume one by the December Day Conference 2010. Elections for the new EMB took place in November 2009 with nominations sought from across VSSN's membership. In addition, the elected EMB appointed the editorial team, in consultation with the publishers. With advice from the EMB, the editorial team is responsible for the content of the journal. Prior to this, the Steering Group acted as the Editorial Management Board and the Editorial Team. With The Policy Press, they worked together to establish the format of the journal; develop the governance and price structures; recruit an international advisory board (of 16 eminent members); and produce the first issues.

#### VSSN/NCVO Annual Voluntary Sector Research Conference

The sixth VSSN/NCVO annual research conference held in September 2009 at Warwick

University brought together a record 154 participants with an interest in the voluntary sector. This drew in researchers, policy makers and practitioners from Australia, Ireland, Japan, Portugal and the US, as well as a UK audience. With ten panels and a further 18 sessions, a total of 108 papers were presented, giving researchers the opportunity to share their ideas and research findings. These were 'topped and tailed' by a pair of plenary sessions. In the opening plenary Lenka Setkova presented an overview of the Carnegie UK Trust's Inquiry into the Future of Civil Society in the UK and Ireland and stimulated a lively discussion by asking delegates to address some of the key questions with which the inquiry team were still grappling ahead of delivering their final report. Complemented by the final session, Bernard Harris of the University of Southampton reviewed the complex history of the relationship between voluntary action and the state over the past two centuries – offering intellectual reflections as well as practice and policy relevance.

We are grateful to colleagues at NCVO for their work on the conference. We are also grateful to Joanna Stuart for organising the New Researchers' element within the conference, which continues to grow in popularity.

#### Day seminars

Two successful day conferences were held during the course of the year, continuing to provide learning and networking opportunities. The Third Sector Research Centre at the University of Birmingham hosted the December 2009 Day Conference. There were five papers on different aspects of the third sector; all of which reported on (recent and ongoing) empirical work. Forty-three people took part in what proved to be an interesting and engaging set of discussions. The May 2010 Day Conference took place at Sheffield Hallam University in Sheffield. Professor Gareth Morgan opened the conference on 'Governance and Regulation in the Voluntary Sector' and five papers were presented to 45 members and guests.

We are grateful to both Universities and our colleagues therein for hosting these events.

#### Online directory

Making use of social networking technology, a new online VSSN Members Research Directory was launched in August 2009. The new format for the Directory gives members direct access to an online profile page that shows information they provide about their organisation, role, events, and research interests. The directory is available to the public as a showcase of members' work, although only paid-up members are able to upload information. It is part of our ongoing work to update the VSSN website and improve services to members.

In addition, we have continued to add to the Course Directory, which contains details of many third sector courses offered by universities around the country.

#### Membership

VSSN's membership continues to grow. At 31 July 2010 there were 111 individual (2009: 115) and 13 organisational members (2009: 12) covering 60 individuals, giving a total of 171 formal members (entitled to vote) compared with 163 in 2009. A detailed strategy is under development to strengthen and market VSSN's membership package with the introduction of

Voluntary Sector Review as a key benefit.

#### E-mail discussion list:

Both members and non-members can register as subscribers to the VSSN e-mail discussion list. The number of users grows yearly and as of 8 November 2010 there are 478 users. This provides a space for lively debate among colleagues and an important point of information sharing.

We are grateful to Jill Mordaunt who continues to perform an excellent role as discussion list moderator.

#### Website:

Regular updates, conference reports, member contact details and links have been added to the website (<a href="www.vssn.org.uk">www.vssn.org.uk</a>) throughout the year. There is growing use of the website: between the 1 August 2009 and 31 July 2010, the site received an average of 450 unique visitors per month compared with 390 the previous year.

With the help of web agency Joomkit, the web team (Veronique Jochum and Mike Aiken from the steering group and Nick Plant our e-services advisor) has been working on a new version of the VSSN website using the Open Source CMS (Content Management System) Joomla. The new website will be completed in 2011.

#### **Building partnerships:**

Members of the Steering Group have continued to meet with the Knowledge Transfer Team at the Economic and Social Research Council (ESRC) to strengthen the relationship and to continue to explore areas for potential collaboration. Meanwhile, our successful partnership with NCVO goes from strength to strength, particularly through our collaboration around the Annual Research Conference (see above). Additional networks are being established and maintained with a range of other organisations, both in the UK and overseas.

#### **Steering Group meetings:**

The Steering Group has met three times during the year, with two meetings coinciding with the day seminars and a further full day meeting held in the spring. In addition, the Steering Group has also met virtually via its email discussion list throughout the year, ensuring that communication and work continues effectively between meetings.

The Steering Group has taken into account the Charity Commission's guidance on public benefit in planning the charity's activities.

Throughout these discussions, the Steering Group has considered that VSSN is seeking to advance education and research concerning the voluntary sector for the benefit of the wider public. All VSSN events are widely publicised and open to anyone interested, with only modest fees to attend. The launch of *Voluntary Sector Review* is an important step in enabling research work on the voluntary sector to reach as many people as possible.

#### VSR Editorial Management Board:

The VSR EMB met at the last December day conference in Birmingham in 2009. A further two meetings were held in 2010. As the journal is established and the editorial processes are now running smoothly, much of the work of the EMB can be done through virtual consultation via the email list, so one formal meeting a year should be adequate. The EMB have agreed to organise one-day meetings each year in the mid autumn to tie in with the publisher's annual planning cycle; and, if needed, there will also be a short meetings at the annual research conference or day conferences.

#### Executive Officer:

The three-year contract with the Association of University Administrators (AUA) to provide an Executive Officer function for VSSN came to an end in March 2009. Subsequently, a new tender was advertised on the VSSN website. The successful applicant (of three) is Appleby, with the role of Executive Officer fulfilled by Sonia Liff. The SG has seen substantial efforts from Appleby to ensure a smooth transition from AUA and significant improvements in the way that enquiries, membership and other supporting work are handled.

A particular thanks to Sonia Liff who, as Executive Officer, has handled the transition and teething problems effectively and efficiently.

#### Financial Review

The trustees have elected to prepare the accounts on a receipts and payments basis in accordance with s42(3) of the Charities Act 1993 and applying relevant recommendations issued by the Charity Commission in relation to the presentation of receipts and payments accounts.

The income of VSSN is not sufficient to require audit or independent examination of the accounts, but the trustees have conducted individual checks on the figures before approving the accounts.

During the year VSSN has markedly increased its activities in relation to publications and web development, as well as launching its journal, and this increased level of activity is reflected in higher income and expenditure figures compared with last year.

The level of VSSN membership subscriptions attracted during the year increased to cover the costs of the additional benefit of *Voluntary Sector Review*, the new VSSN journal, and exceeded minimum expectations.

During the year, a total grant of £10,000 was paid to the University of Bristol/ Policy Press for the development costs of *Voluntary Sector Review*, funded from support received for this purpose from the Big Lottery Fund and TSRC.

The accounts show that the charity had a surplus of receipts over payments of £3,419 in 2009/2010: of this, £640 was due to Policy Press to cover a supplementary payment arising

from additional VSSN subscriptions in 2009/2010. This had not been paid at the time of preparing these accounts (though has since), and is included in the Statement of Liabilities.

The remaining surplus is partly due to receipt during the year of some donations, and of increased income from seminar fees and from membership subscriptions, including of advanced membership payments for 2010/2011. It is also due to savings made when the current contract with AUA for membership services was terminated. There was a two-month gap before the new contract with Appleby commenced.

#### Reserves policy

VSSN has a formal *reserves policy*. This needs to take account of increased obligations arising from VSSN's commitment to Policy Press for supporting the *Voluntary Sector Review*, and its continuing annual contracted Executive Officer services.

Subscriptions are received mainly at the start of the year, but the obligations for the Executive Officer (EO) role arise quarterly and are subject to 3 months' notice, so the Steering Group considers that at any time VSSN must have sufficient funds in hand to cover both the current and next quarter for the EO contract. This amounts to £1,500 and is included on the Statement of Assets and Liabilities. The additional minimum obligation for VSR is £2600, and at this developmental stage in the life of the Journal, the Committee would prefer to allow for the whole of this amount as a creditor on the Statement of Assets and Liabilities. It is estimated that VSSN should allow £1000 for other expenses such as possible venue hire costs or any shortfall in revenue taken to cover the costs of day seminars etc, in the Reserves.

As at 31.7.2010 the total balance of the General Fund was £9,115 in monetary terms, but as shown on the Statement of Assets and Liabilities, £6,770 is liable after year end, leaving an effective balance of £2,345, comfortably above the minimum level of reserves needed.

We would like to record our thanks to Sonia Liff of Appleby for revising VSSN's financial recording systems, and for the high quality of financial reports now received. This has been extremely helpful in a year, which has seen such an increased level of activity.

We are very grateful to Gareth Morgan for his continued informal review of the presentation of our financial reporting, but we stress that he is *not* acting as independent examiner for VSSN.

#### **Approval**

The trustees acknowledge their responsibilities for keeping proper accounting records for the charity, for safeguarding the charity's funds from loss, and for preparing an Annual Report and Annual Accounts to comply with the requirements of the Charities Act 1993.

This Annual Report has been prepared to comply with the Charities (Accounts and Reports) Regulations 2008, taking advantage of simplifications available to non-auditable charities. It was approved by the trustees (Steering Group) on {xxxxx} and signed on their behalf by:
