Steering Group Report: activities undertaken for public benefit by the Voluntary Sector Studies Network (VSSN) during the year ending 31 July 2013

Chair's Introduction

It has been another year of solid progress for VSSN. Membership numbers have held up well despite the very challenging economic circumstances. Our journal, *Voluntary Sector Review*, has continued to publish articles of a high quality on a variety of areas of interest and concern. Our new online payments system has proved its worth and we continue to benefit from the administrative support provided by Appleby Ltd. Key highlights of the year are summarised below under activities, management and organisation, and financial review.

1. The activities of VSSN

VSSN's journal, Voluntary Sector Review

VSSN's interdisciplinary journal, *Voluntary Sector Review* (VSR), published by The Policy Press, is now in its fourth year, with three issues per annum in March, July and November. A print copy is a VSSN membership benefit. *VSR* has been chosen as the official journal of the European Research Network on Philanthropy (ERNOP), and it is available at a substantial discount to members of the International Society for Third-Sector Research (ISTR).

The journal is designed to appeal to a wide readership, and each issue, of around 150 pages, includes research articles, practice papers and policy reviews as well as book reviews.

In the year to 31 July 2013, the VSR's online abstracts were viewed nearly 39,000 times and full-text articles were downloaded over 3,500 times. The journal is therefore a very good route for contributors to share their work on the voluntary sector with a wide audience. The number of subscriptions has increased again this year, though all VSSN members are still strongly encouraged to persuade their institutions to take out (and continue) subscriptions to ensure the financial sustainability of the journal.

Membership of the Editorial Team rotates; this year, we record our thanks to Julie Charlesworth, whose term as policy review section editor came to an end; she was replaced by Cathy Pharoah.

The publisher implemented an online journal management system – Editorial Manager – in October 2012, which has automated much of the processing of articles, from receipt, through review, editing and revisions, to publication. Another innovation has been 'fast tracking', through which articles are made available on the IgentaConnect VSR website as soon as they have been accepted, in advance of appearing in the print version of the journal.

A new development for the next year is the inclusion of a Debate section in one issue, in which renowned scholars will respond to an article published in the journal a year earlier and the article's author will reply. There are also plans for themed issues, one of which will

draw on papers presented at the 2013 ERNOP conference.

VSSN is grateful to The Policy Press for the enthusiasm and expertise it has brought to this venture, and the resources it is devoting to making it a success.

VSR Editorial Management Board

The VSR EMB has an annual meeting in the autumn, which is linked to The Policy Press's planning timetable. As the journal is well established and the editorial processes are running smoothly, much of the work of the EMB can be done through virtual consultation via email.

The EMB has established a timetable for the replacement of editorial roles in rotation. The Practice Papers Editor will be replaced in December 2013, and a replacement Editor (or Editors) is being sought so that there can be a period of handover with the current Editor, who will retire in December 2014.

Website

The VSSN website continues to play a key role in communicating VSSN's activities. Appleby Ltd has continued regularly to update the site with the latest content, and online payments are working well and making the process of booking events and paying for membership easier for members and VSSN staff.

We are currently undertaking an upgrade of the website in order to bring the directory of members onto the site rather than hosted externally through Ning. The upgrade will also expand the range of content available on the site and make it better when viewed by mobile phone and tablet users.

Day Conferences

Two successful day conferences were held during the year, although attendances were slightly lower than usual. Nevertheless, the conferences continue to provide an important showcase for new research and reflections and to provide opportunities for networking amongst participants.

Wales Council for Voluntary Action hosted the December 2012 Day Conference at Cardiff University, in partnership with WISERD - the Wales Institute for Social and Economic Research, Data and Methods. The programme consisted of five papers on a variety of topics, including the development of a code of practice for relationship between the private and voluntary sectors, voluntary sector competition for European funding, online campaigning, the role of lunch clubs and the challenges faced by trustees of local charities. Proceedings at the May 2013 Day Conference at London South Bank University were kicked off with a keynote review by Professor David Horton Smith, Fulbright visiting scholar, who spoke about the development of research in the voluntary and nonprofit sector. This was followed by excellent presentations on voluntary sector involvement in criminal justice,

VSSN/NCVO Annual Voluntary Sector Research Conference, 2012

The Annual Research Conference, which is jointly organised by VSSN and NCVO, took place on 10 and 11 September 2011 at the University of Birmingham. It brought together academics, practitioners and policymakers with a shared interest in voluntary sector research and provided an opportunity for them to discuss new research and network.

The opening address was given by Professor Dennis Young of Georgia State University whose theme was 'A Benefits Approach to Financing Nonprofit Organizations' and more than 70 research papers were presented at the conference. They covered a wide variety of topics and themes including - among many others - challenges for governance and management; partnerships and cross-sector relationships; the impact of policy changes on the sector; volunteering; community and grassroots activity; corporate philanthropy, grantmaking and individual giving; and charity law, regulation and accountability.

The conference also provided an opportunity for those who were relatively new to the research or the field to present their work in a supportive environment. These New Researchers Sessions are an established part of the event: this year was the ninth time it has been included and is described below.

New Researchers

The free New Researchers Sessions took place alongside the VSSN/NCVO Research Conference in September 2012. They provide a route for emerging scholars or new researchers in the field to share their work and mingle with delegates from the main event. VSSN also provides a New Researchers Prize, consisting of a year's free membership, for the best paper. The event was organised with the support of Matthew Hill from the Institute for Volunteering Research, who worked alongside two VSSN committee members in developing the work.

During the year work began to address some of the challenges facing the delivery of the event particularly around a lack of funding which hampered the event reaching its full potential. In particular this meant finding ways, in the context of VSSN being a small organisation, to tackle the following issues:

- Finding ways to support travel costs and accommodation for new researchers without access to institutional/academic funds
- Seeking ways to offer new researchers without funds full access to informal networking with delegates at the main conference during meal breaks and in social spaces

- Including abstracts and publicity about the New Researchers Sessions in the main conference programme to enable mutual cross-networking between the event and the main conference without placing extra financial burdens on the main conference
- Providing access for new researchers without funds to attend the main conference plenaries.

VSSN has not be able to afford the costs associated with travel expenses for speakers and chairs who are not already attending the main conference nor for the production of post-conference dissemination material such as a research report and web-based learning materials for new researchers. As such, the New Researchers Sessions, and the associated network they create, had yet to realise their full potential. To address these problems, VSSN applied to the Economic and Social Research Council (ESRC) for a grant to develop the New Researchers Sessions at the VSSN/NCVO annual research conference in September 2013 and beyond, which was successful. VSSN is grateful for the award of £4,270 which enables us to tackle the main issues.

Development questions for the future include: securing funding for future New Researchers Sessions; developing connections with similar networks in adjacent fields; considering a small mid-year one-day new researcher workshop/conference in the Spring.

A Twitter account for new researchers and the entire VSSN membership was established in July 2013 and will be co-ordinated by Anjelica Finnegan. It is hoped that the Twitter account will be a useful tool to promote VSSN events such as the New Researchers Sessions, annual conference and one-day conferences. VSSN's Twitter handle (or username) is @VSSN_uk.

Membership

At 31 July 2013 VSSN had 137 individual and 7 organisation members covering 28 individuals (compared to 140 individual and 7 organisation members covering 30 individuals in 2012), giving a total of 165 members (compared with 170 members in 2012). There is a growing, but still small, number of non-UK members. These are primarily from outside Europe — including Australia and New Zealand. This increase has been supported by our online payment system which reduces the cost of paying via other currencies. Members continue to be positive about membership in terms both of specific benefits such as the *Voluntary Sector Review*, and in the wider sense of being part of a community of people with similar interests.

The VSSN Steering Group has reviewed trends in membership and considered ways of growing membership, which has been broadly stable since 2009. However this stability in headline numbers masks quite significant changes in the numbers of members leaving and joining. Between 31 July 2012 and 31 July 2013 VSSN lost 24% of its members (34) through non-renewal and gained 31 new members. Some turnover of membership is inevitable, as people change jobs, retire, and so on, but a high level of change probably also reflects continuing difficult economic circumstances for both academics and practitioners and the organisations that employ them. In recognition of these circumstances the Steering Group decided not to increase subscription rates for another year and recognise that actively recruiting new members will always need to be part of maintaining membership. At a

strategy meeting held in June 2013 the SG discussed ways in which the public profile of VSSN could be raised, networking with other bodies could increase, and the membership offer could be kept strong.

It is reassuring to know that members are upbeat on the benefits of membership and the Steering Group is keen to ensure that this optimism is maintained. Improvements to the website, including extra functionality and a more user-friendly interface, have helped enhanced services for members and non-members. The SG has discussed various future membership and marketing matters during the year including:

- Different membership benefits for organisations and individuals, to the extent to which they are in line with what is wanted, and the value of rewarding long periods of unbroken membership
- Reasons for a relatively high turnover of members each year, asking members why they leave, offering discounts for new members, early renewal, and multi-year memberships
- Broader examination of membership fee structures balancing potential cash gains against member losses, concessions for members on lower incomes and higher fees for higher earners
- Revenues from conference and what impacts on attendance apart from cost such as location, distance to travel, competing or complementary conferences, and who attends
- VSSN public profile, exhibiting at relevant places, approaching chief officers in larger non profit research and other organisations

Finally, it is has been felt to be crucial to get member participation in thinking about the role and purpose of VSSN in the future.

Email Discussion List

There has been a slight dip in the number of people subscribing to the VSSN e-discussion list this year - falling from 522 subscribers in September 2012 to 505 subscribers as of 15 August 2013. The list, however, continues to attract both members and non-members and to provide a lively forum for debate and information sharing. Recent discussion topics have included organisational sustainability and resilience and the future of voluntary services. The list also serves as a useful resource for colleagues seeking out existing research evidence and references, contacting potential research participants, and promoting events and publications. We are grateful to all our contributors for their ongoing input and commitment.

2. The Organisation and Management of VSSN

Building Partnerships

The successful partnership with NCVO continues, particularly through VSSN's collaboration around the Annual Research Conference. Formal links are maintained with a range of other organisations, through our website, and this is an area to which more attention will be given in the future.

Steering Group meetings

The Steering Group met four times during the year. Meetings were held after both VSSN Day Conferences and after the Annual Conference and an additional meeting to discuss future strategy was convened in June, 2013. In addition, the Steering Group uses its email discussion list to progress business between meetings.

At its strategy meeting the Group agreed that it needed to raise the profile of VSSN and take a more proactive approach to its role. This would involve:

- seeking a public profile by commenting on appropriate issues of policy and practice which affected the voluntary sector research community;
- making use of social media to increase awareness of VSSN;
- using the website we have in development to promote more networking between VSSN members;
- creating more and better linkages with external bodies such as foundations and other scholarly bodies with a view to joint activity; and
- redesign the day conferences to focus on 'hot issues'; involve practitioners; and experiment with innovative formats.

Public Benefit

One of the Steering Group's main responsibilities is to ensure that VSSN pursues its stated aim as a charity of advancing education and research concerning the voluntary sector in ways that provide a benefit to the wider public. All VSSN events are widely publicised and open to all, with only modest fees to attend. Similarly our online discussion list is open to anyone to join. Furthermore, the *Voluntary Sector Review* is now an integral part of the VSSN's work and is an important vehicle in enabling research work on the voluntary sector to reach as many people as possible.

Executive Office

In May Appleby Ltd completed its three-year contract with VSSN for the provision of the Executive Office. A new contract is now in place for the next 3 years. Appleby Ltd has continued to carry out a wide range of activities including those related to membership, finances, website updates and day conferences. It also supports the VSSN Steering Group in taking forward new developments.

3. VSSN's Financial Review

The trustees have continued to prepare the accounts on a receipts and payments basis as permitted by the Charities Act 2011 and have taken account of recommendations issued by the Charity Commission for presentation of accounts on this basis.

While the income of VSSN is not sufficient to require audit or independent examination of the accounts, the trustees have conducted individual checks on the figures before approving the accounts.

Receipts and payments

During the year income from subscriptions for VSSN's membership package, which includes its journal, *Voluntary Sector Review*, and a preferential rate of registration for day seminars, declined slightly from £8,349.57 to £8,150.00. The proportion of subscriptions paid on an organisational basis increased from 15% to 18%.

During the year income from day seminars decreased by a fifth from £2,499.00 to £2,050.00, and the surplus generated by these events decreased by more than half (from £1,833.12 to £807.17), mainly due to an increase in costs of accommodation and catering. The proportion of fees paid by non-members decreased from 38% to 32%.

During the year VSSN received a grant of £2,000.00 from NCVO for work in support of the annual VSSN/NCVO research conference, and a grant of £4,270.00 from the Economic and Social Research Council (ESRC) for support of new researchers' participation in the 2013 conference and generally.

Obligations at year end

There were a number of obligations at year end. These consisted of:

- Current liabilities of £5,026.07. These included sums owed for financial year 2012-13 but not paid out before the end of that year: final payment for room hire for a meeting of the Steering Group (£96.07); the quarterly fee payable to the Executive Officer for June to August 2013 (£1,250.00); and payments to the Policy Press for the Voluntary Sector Review (£3,680.00).
- Other binding long-term commitments of £6,660.00. These included the fees of the
 Executive Officer for at least one quarter plus an additional quarter's notice period;
 (£2,500.00); likely expenses of the Executive Officer (£200.00); payments to the
 Policy Press for the Voluntary Sector Review (estimated) (£3,660.00); and a
 contingency for maintaining and upgrading VSSN's website (£300.00).
- Deferred income of £490.00. This included subscriptions for financial year 2013-14 paid in advance.

Reserves policy

VSSN has a formal reserves policy. This takes account of obligations arising from VSSN's commitment to the Policy Press for supporting the *Voluntary Sector Review* and its contract with Appleby Ltd for the services of the Executive Officer.

As at 31 July 2013 VSSN's total balance at bank was £24,747.03 of which £20,477.03 was unrestricted and £4,270.00 was restricted (grant from the ESRC to support new researchers' participation in the annual conference and generally). Allowing for current liabilities at year's end of £5,026.07, the effective balance was £19,720.96.

Allowing for other binding commitments as per VSSN's reserves policy (£6,160.00), the effective available balance at year's end was £13,560.96.

These figures mean that VSSN's current financial position is comfortable and substantially improved upon that in the previous year.

However, VSSN's financial position is determined by its capacity to attract members and to encourage attendance at its day seminars. There is, therefore, a need to continue vigorously to promote memberships (especially from among the large number of those on its webbased mailing list) and to encourage attendance at day seminars and, where possible, to seek additional funding and lower costs for those seminars.

We would like to record our thanks to Sonia Liff and her colleague at Appleby Ltd for continuing to develop VSSN's financial recording and payments systems and for the high quality of financial reporting they produce. This has been invaluable in helping VSSN increase the effectiveness of its financial planning and provide better services to members.

Approval

The trustees acknowledge their responsibilities for keeping proper accounting records for the charity, safeguarding the charity's funds from loss and preparing an Annual Report and Annual Accounts to comply with the requirements of the Charities Act 2011.

This Annual Report has been prepared to comply with the Charities (Accounts and Reports) Regulations 2008, taking advantage of simplifications available to non-auditable charities. It was approved by the trustees (Steering Group) on 28 November 2013 and signed on their behalf by:

Notes to the Accounts

- 1. Members of the Steering Group or their institutions normally meet their own travel expenses when attending meetings of the Steering Group held on the same day as VSSN's day seminars and the annual conference. VSSN pays the travel expenses of the Executive Officer to day seminars and the annual conference.
- 2. VSSN has contracted with Appleby Ltd to provide the role of Executive Officer. The first contract was for a fee of £4,500.00 per annum for three years between June 2010 to July 2013 (subject to three months' notice by either party). The second contract was for a fee of £5,000.00 from June 2013 to July 2014, £5,150.00 from June 2014 to July 2015 and £5,304 from June 2015 to July 2016 (subject to three months' notice by either party).
- 3. VSSN has some fixed assets in the form of banner stands and a table stand, but as these personalised to VSSN they do not have any disposal value to show on the Statement of Assets and Liabilities.
- 4. VSSN's contract with the Policy Press for the publication of the *Voluntary Sector Review* specifies two payments, the first a basic payment of £2,600.00 per year ("minimum obligation") and the second a payment based on the number and income category of VSSN's members ("supplementary obligation"). The former is fixed and the second is variable. Payments are made in arrears.
